



Privacy Policy

What data we need

The personal data we collect from you includes:

- questions, queries, or feedback you leave, including your email address if you contact Aquaforce Plumbing Solutions
- your email address and subscription preferences when you sign up to our email alerts
- how you use our emails – for example whether you open them, and which links you click on
- your Internet Protocol (IP) address, and details of which version of web browser you used
- information on how you use the site, using cookies and page tagging techniques

The legal basis for processing this data is to perform a task associated with providing you with the services you may be seeking and to improve the offerings of Aquaforce Plumbing Solutions.

Why we need it

We use Google Analytics software to collect information about how you use Aquaforcegroup.co.uk. We do this to help make sure the site is meeting the needs of its users and to help us make improvements, for example improving site search.

Google Analytics stores information about:

- the pages you visit on Aquaforcegroup.co.uk
- how long you spend on each Aquaforcegroup.co.uk page
- how you got to the site
- what you click on while you're visiting the site

We do not collect or store your personal information (for example your name or address) so this information cannot be used to identify who you are.

We also collect data to:

- improve the site by monitoring how you use it
- gather feedback to improve our services, for example our email alerts
- respond to any feedback you send us if you've asked us to
- send email alerts to users who request them
- allow you to access government services and make transactions
- provide you with information about Aquaforce Plumbing Solution services if you want it

What we do with your data

We will not:

- sell or rent your data to third parties
- share your data with third parties for marketing purposes

We will share your data if we are required to do so by law – for example, by court order, or to prevent fraud or other crime.

How long we keep your data

We will only retain your personal data for as long as:

- it is needed for the purposes set out in this document
- the law requires us to

In general, this means that we will only hold your personal data for a minimum of 1 year and a maximum of 7 years.

Children's privacy protection

Our services are not designed for, or intentionally targeted at, children 13 years of age or younger. We do not intentionally collect or maintain data about anyone under the age of 13.

Where your data is processed and stored

We design, build, and run our systems to make sure that your data is as safe as possible at any stage, both while it's processed and when it's stored.

Your personal data throughout the course of its processing will be conducted within the United Kingdom (UK).

How we protect your data and keep it secure

We are committed to doing all that we can to keep your data secure. We have set up systems and processes to prevent unauthorised access or disclosure of your data – for example, we protect your data using varying levels of encryption.

Your rights

You have the right to request:

- information about how your personal data is processed
- a copy of that personal data
- that anything inaccurate in your personal data is corrected immediately

You can also:

- raise an objection about how your personal data is processed
- request that your personal data is erased if there is no longer a justification for it
- ask that the processing of your personal data is restricted in certain circumstances


